Accelerated program: Completion of a college program of st d in fe er than the s al n mber of ears, most often b attending s mmer sessions and carr ing e tra co rses d ring the reg lar academic term.

**Admitted student:** Applicant ho is offered admission to a degree-granting program at o r instit tion.

\*Adult student services: Admission assistance, s pport, orientation, and other ser ices e pressl for ad lts ho ha e started college for the first time, or ho are re-entering after a lapse of a fe ears.

American Indian or Alaska Native: A person has ing origins in an of the original peoples of North and So th America (incl. ding Central America) and maintaining tribal affiliation or commonity attachment.

**Applicant (first-time, first year):** An indi id al ho has f lfilled the instit tion s req irements to be considered for admission (incl ding pa ment or ai ing of the application fee, if an ) and ho has been notified of one of the follo ing actions: admission, nonadmission, placement on aiting list, or application ithdra n (b applicant or instit tion).

**Application fee:** That amo nt of mone that an instit tion charges for processing a st dent s application for acceptance. This amo nt is *not* creditable to ard t ition and req ired fees, nor is it ref ndable if the st dent is not admitted to the instit tion.

**Asian:** A person ha ing origins in an of the original peoples of the Far East, So theast Asia, or the Indian s bcontinent, incl ding, for e ample, Cambodia, China, India, Japan, Korea, Mala sia, Pakistan, the Philippine Islands, Thailand, and Vietnam.

Associate degree: An a ard that normall req ires at least to b t less than for ears of f ll-time eq i alent college ork.

**Bachelor's degree:** An a ard (baccala reate or eq i alent degree, as determined b the Secretar of the U.S. Department of Ed cation) that normall req ires at least fo r ears b t *not* more than fi e ears of f ll-time eq i alent college-le el ork. This incl des ALL bachelor s degrees conferred in a fi e- ear cooperati e ( ork-st d plan) program. (A cooperati e plan pro ides for alternate class attendance and emplo ment in b siness, ind str, or go ernment; th s, it allo s st dents to combine act al ork

e perience ith their college st dies.) Also, it incl des bachelor s degrees in hich the normal for ears of ork are completed in three ears.

Black or African American: A person ha ing origins in an of the black racial gro ps of Africa.

**Books and supplies (costs):** A erage cost of books and s pplies. Do not incl de n s al costs for special gro ps of st dents (e.g., engineering or art majors), nless the constit te the majorit of st dents at o r instit tion.

**Calendar system:** The method b hich an instit tion str ct res most of its co rses for the academic ear.

Campus Ministry: Religio s st dent organi ations (denominational or nondenominational) de oted to fostering religio s life on college camp ses. Ma also refer to Camp s Cr sade for Christ, an interdenominational Christian organi ation.

\*Career and placement services: A range of ser ices, incl ding (often) the follo ing: coordination of isits of emplo ers to camp s; aptit de and ocational testing; interest in entories, personal co nseling; help in res me riting, inter ie ing, la nching the job search; listings for those st dents desiring emplo ment and those seeking permanent positions; establishment of a permanent reference folder; career reso ree materials.

Carnegie units: One ear of st d or the eq i alent in a secondar school s bject.

Certificate: See Postsecondary award, certificate, or diploma.

Class rank: The relatien merical position of a st dent in his or her grad ating class, calculated be the high school on the basis of grade-point a erage, hether eighted or n eighted.

**College-preparatory program:** Co rses in academic s bjects (English, histor and social st dies, foreign lang ages, mathematics, science, and the arts) that stress preparation for college or ni ersit st d.

**Common Application:** The standard application form distrib ted b the National Association of Secondar School Principals for a large n mber of pri ate colleges ho are members of the Common Application Gro p.

\*Community service program: Referral center for st dents ishing to perform of nteer ork in the comm nit or participate in of nteer actifities coordinated by academic departments.

**Commuter:** A st dent ho li es off camp s in ho sing that is not o ned b , operated b , or affiliated ith the college. This categor incl des st dents ho comm te from home and st dents ho ha e mo ed to the area to attend college.

Comprehensive transition and postsecondary program for students with intellectual disabilities: Programs designed to s prot postsecondar st dents ith intellect all disabilities obtain instriction in academic, career and technical, and independent lining s bjects in preparation for employment.

**Clock hour:** A nit of meas re that represents an hor of sched led instriction given to st dents. Also referred to as contact hor.

Continuous basis (for program enrollment): A calendar s stem classification that is sed b instit tions that enroll st dents at an time d ring the academic ear. For e ample, a cosmetolog school or a ord processing school might allo st dents to enroll and begin st dies at ario s times, ith no req irement that classes begin on a certain date.

Cooperative education program: A program that pro ides for alternate class attendance and emplo ment in b siness, ind str, or go ernment.

Cooperative housing: College-o ned, -operated, or -affiliated ho sing in hich st dents share food and ho sing e penses and participate in ho sehold chores to red ce li ing e penses.

\*Counseling service: Acti ities designed to assist st dents in making plans and decisions related to their ed cation, career, or personal de elopment.

Credit: Recognition of attendance or performance in an instr ctional acti it (co rse or program) that can be applied b a recipient to ard the req irements for a degree, diploma, certificate, or recogni ed postsecondar credential.

Credit course: A co rse that, if s ccessf ll completed, can be applied to ard the n mber of co rses req ired for achie ing a degree, diploma, certificate, or other recogni ed postsecondar credential.

**Credit hour:** A nit of meas re representing an hor (50 min tes) of instriction of er a 15- eek period in a semester or trimester sistem or a 10- eek period in a quarter sistem. It is applied to and the total number of hor since ded for completing the requirements of a degree, diploma, certificate, or recognised postsecondar credential.

Cross-registration: As stem hereb st dents enrolled at one instit tion ma take co rses at another instit tion itho that ing to apple to the second institution.

**Deferred admission:** The practice of permitting admitted st dents to postpone enrollment, s all for a period of one academic term or one ear.

**Degree:** An a ard conferred b a college, ni ersit, or other postsecondar ed cation instit tion as official recognition for the s ccessf l completion of a program of st dies.

**Degree-seeking students:** St dents enrolled in corses for credit ho are recognied by the institution as seeking a degree or recognied postsecondar credential. At the indegrad at eleel, this is intended to include st dents enrolled in ocational or occ pational programs.

**Differs by program (calendar system):** A calendar s stem classification that is sed b instit tions that ha e occ pational/ ocational programs of ar ing length. These schools ma enroll st dents at specific times depending on the program desired. For e ample, a school might offer a t o-month program in Jan ar, March, Ma, September, and No ember; and a three-month program in Jan ar, April, and October.

Diploma: See Postsecondary award, certificate, or diploma.

**Distance learning:** An option for earning co rse credit at off-camp s locations ia cable tele ision, internet, satellite classes, ideotapes, correspondence co rses, or other means.

**Doctor's degree-research/scholarship**: A Ph.D. or other doctor's degree that req ires ad anced ork be ond the master s le el, incl ding the preparation and defense of a dissertation based on original research, or the planning and e ec tion of an original project demonstrating s betantial artistic or scholarl achie ement. Some e amples of this t pe of degree ma incl de Ed.D., D.M.A., D.B.A., D.Sc., D.A., or D.M, and others, as designated b the a arding instit tion.

**Doctor's degree-professional practice**: A doctor s degree that is conferred pon completion of a program pro iding the kno ledge and skills for the recognition, credential, or license req ired for professional practice. The degree is a arded after a period of st d s ch that the total time to the degree, incl ding both pre-professional and professional preparation, eq als at least si f ll-time eq i alent academic ears. Some of these degrees ere former classified as first-professional and ma incl de: Chiropractic (D.C. or D.C.M.); Dentistr (D.D.S. or D.M.D.); La (L.L.B. or J.D.); Medicine (M.D.); Optometr (O.D.); Osteopathic Medicine (D.O); Pharmac (Pharm.D.); Podiatr (D.P.M., Pod.D., D.P.); or, Veterinar Medicine (D.V.M.), and others, as designated b the a arding instit tion.

**Doctor's degree-other**: A doctor s degree that does not meet the definition of a doctor s degree - research/scholarship or a doctor s degree - professional practice.

**Double major:** Program in hich st dents ma complete t o ndergrad ate programs of st d sim Itaneo sl.

**Dual enrollment:** A program thro gh hich high school st dents ma enroll in college co rses hile still enrolled in high school. St dents are not req ired to appl for admission to the college in order to participate.

**Early action plan:** An admission plan that allo s st dents to appl and be notified of an admission decision ell in ad ance of the reg lar notification dates. If admitted, the candidate is not committed to enroll; the st dent ma repl to the offer nder the college s reg lar repl polic.

**Early admission:** A polic nder hich st dents ho ha e not completed high school are admitted and enroll f ll time in college, s all after completion of their j nior ear.

**Early decision plan:** A plan that permits st dents to appl and be notified of an admission decision (and financial aid offer if applicable) ell in ad ance of the reg lar notification date. Applicants agree to accept an offer of admission and, if admitted, to ithdra their applications from other colleges. There are three possible decisions for earl decision applicants: admitted, denied, or not admitted b t for arded for consideration ith the reg lar applicant pool, itho t prej dice.

English as a Second Language (ESL): A corse of st d designed specifical for st dents hose native language is not English.

**Exchange student program-domestic:** An arrangement bet een a st dent and a college that permits st d for a semester or more at another college in the United States itho t e tending the amo nt of time req ired for a degree. See also Study abroad.

**External degree program:** A program of st d in hich st dents earn credits to ard a degree thro gh independent st d, college co rses, proficience e aminations, and personal e perience. E ternal degree programs req ire minimal or no classroom attendance.

Extracurricular activities (as admission factor): Special consideration in the admissions process gi en for participation in both school and nonschool-related acti ities of interest to the college, s ch as cl bs, hobbies, st dent go ernment, athletics, performing arts, etc.

**First-time student:** A st dent attending an instit tion for the first time at the le el enrolled. Incl des st dents enrolled in the fall term ho attended a postsecondar instit tion for the first time at the same le el in the prior s mmer term. Also incl des st dents ho entered ith ad anced standing (college credit earned before grad ation from high school).

**First-time, first-year student:** A st dent attending an instit tion for the first time at the indergrad ate le el. Incl des st dents enrolled in the fall term ho attended college for the first time in the prior s mmer term. Also incl des st dents ho entered ith ad anced standing (college credits earned before grad ation from high school).

**First-year student:** A st dent ho has completed less than the eq i alent of 1 f ll ear of ndergrad ate ork; that is, less than 30 semester ho rs (in a 120-ho r degree program) or less than 900 clock ho rs.

\*New student orientation: Orientation addressing the academic, social, emotional, and intellect all iss es in ol ed in beginning college. Ma be a fe ho rs or a fe da s in length; at some colleges, there is a fee.

Food (charges): Ass me a erage cost for 19 meals per eek or the ma im m meal plan.

**Full-time student (undergraduate):** A st dent enrolled for 12 or more semester credits, 12 or more q arter credits, or 24 or more clock ho rs a eek each term.

Geographical residence (as admission factor): Special consideration in the admission process gi en to st dents from a partic lar region, state, or co ntr of residence.

**Grade-point average (academic high school GPA):** The s m of grade points a st dent has earned in secondar school di ided b the n mber of co rses taken. The most common s stem of assigning n mbers to grades co nts fo r points for an A, three points for a B, t o points for a C, one point for a D, and no points for an E or F. Un eighted GPA s assign the same eight to each co rse. Weighting gi es st dents additional points for their grades in ad anced or honors co rses.

**Graduate student:** A st dent ho holds a bachelor s or eq i alent, and is taking co rses at the post-baccala reate le el.

\*Health services: Free or lo cost on-camp s primar and pre enti e health care a ailable to st dents.

**High school diploma or recognized equivalent:** A doc ment certif ing the s ccessf 1 completion of a prescribed secondar school program of st dies, or the attainment of satisfactor scores on the Tests of General Ed cational De elopment (GED), or another state-specified e amination.

**Hispanic or Latino:** A person of Me ican, P erto Rican, C ban, So th or Central American, or other Spanish c lt re or origin, regardless of race.

**Honors program:** An special program for er able st dents offering the opport nit for ed cational enrichment, independent st d, acceleration, or some combination of these.

**Independent study:** Academic ork chosen or designed b the st dent ith the appro al of the department concerned, nder an instr ctor s s per ision, and s all ndertaken o tside of the reg lar classroom str ct re.

**In-state tuition:** The t ition charged b instit tions to those st dents ho meet the state s or instit tion s residenc req irements.

## International student: See Nonresident.

**International student group:** St dent gro ps that facilitate c lt ral dialog e, s pport a di erse camp s, assist international st dents in acclimation and creating a social net ork.

**Internship:** An short-term, s per ised ork e perience s all related to a st dent s major field, for hich the st dent earns academic credit. The ork can be f ll- or part-time, on- or off-camp s, paid or npaid.

\*Learning center: Center offering assistance thro gh t tors, orkshops, comp ter programs, or a dio is all eq ipment in reading, riting, math, and skills s ch as taking notes, managing time, taking tests.

\*Legal services: Free or lo cost legal ad ice for a range of iss es (personal and other).

**Liberal arts/career combination:** Program in hich a st dent earns indergrad at degrees in to separate fields, one in a liberal arts major and the other in a professional or specialited major, hether on camp s or through cross-registration.

**Living learning community:** Residential programs that allo st dents to interact ith st dents ho share common interests. In addition to li ing together, st dents ma also participate in shared co rses, special e ents, and gro p ser ice projects.

**Master's degree**: An a ard that req ires the s ccessf l completion of a program of st d of generall one or t o f ll-time eq i alent academic ears of ork be ond the bachelor's degree. Some of these degrees, s ch as those in Theolog (M.Di ., M.H.L./Ra) that ere former classified as "first-professional", ma req ire more than t o f ll-time eq i alent academic ears of ork.

**Minority affiliation (as admission factor):** Special consideration in the admission process for members of designated racial/ethnic minorit gro ps.

\*Minority student center: Center ith programs, acti ities, and/or ser ices intended to enhance the college e perience of st dents of color.

**Model United Nations:** A sim lation acti it foc sing on conflict resol tion, globali ation, and diplomac. Ass ming roles as foreign ambassadors and delegates, st dents cond ct research, engage in debate, draft resol tions, and ma participate in a national Model UN conference.

**Native Hawaiian or Other Pacific Islander:** A person has ing origins in an of the original peoples of Ha aii, G am, Samoa, or other Pacific Islands.

**Nonresident:** A person ho is not a citi en or national of the United States and ho is in this contron a isa or temporar basis and does not have the right to remain indefinitel.

\*On-campus day care: Licensed da care for st dents children ( s all age 3 and p); s all for a fee.

**Open admission:** Admission polic nder hich irt all all secondar school grad ates or st dents ith GED eq i alenc diplomas are admitted itho t regard to academic record, test scores, or other q alifications.

Other expenses (costs): Incl de a erage costs for clothing, la ndr, entertainment, medical (if not a req ired fee), and f rnishings.

**Out-of-state tuition:** The t ition charged b instit tions to those st dents ho do not meet the instit tion s or state s residenc req irements.

**Part-time student (undergraduate):** A st dent enrolled for fe er than 12 credits per semester or q arter, or fe er than 24 clock ho rs a eek each term.

Permanent Resident or other eligible non-citizen: A person ho is not a citi en or national of the United States and ho has been admitted as a legal immigrant for the propose of obtaining permanent resident stat s (and ho holds either a registration card [Form I-551 or I-151], a Temporar Resident Card [Form I-688], or an Arri al-Depart re Record [Form I-94] ith a notation that con e s legal immigrant stat s, s ch as Section 207 Ref gee, Section 208 As lee, Conditional Entrant Parolee or C ban-Haitian).

\*Personal counseling: One-on-one or gro p co nseling ith trained professionals for st dents ho ant to e plore personal, ed cational, or ocational iss es.

**Post-baccalaureate certificate:** An a ard that req ires completion of an organi ed program of st d req iring 18 credit ho rs be ond the bachelor s; designed for persons ho ha e completed a baccala reate degree b t do not meet the req irements of academic degrees carr ing the title of master.

**Post-master's certificate:** An a ard that req ires completion of an organi ed program of st d of 24 credit ho rs be ond the master s degree b t does not meet the req irements of academic degrees at the doctoral le el.

**Postsecondary award, certificate, or diploma:** Incl des the follo ing three IPEDS definitions for postsecondar a ards, certificates, and diplomas of ar ing d rations and credit/contact/clock ho r req irements:

: Req ires completion of an organi ed program of st d at the postsecondar le el (belo the baccala reate degree) in less than 1 academic ear (2 semesters or 3 q arters) or in less than 900 clock ho rs b a st dent enrolled f ll-time.

Req ires completion of an organi ed program of st d at the postsecondar le el (belo the baccala reate degree) in at least 1 b t less than 2 f ll-time eq i alent academic ears, or designed for completion in at least 30 b t less than 60 credit ho rs, or in at least 900 b t less than 1,800 clock ho rs.

Req ires completion of an organi ed program of st d at the postsecondar le el (belo the baccala reate degree) in at least 2 b t less than 4 f ll-time eq i alent academic ears, or designed for completion in at least 60 b t less than 120 credit ho rs, or in at least 1,800 b t less than 3,600 clock ho rs.

**Private institution:** An ed cational instit tion controlled b a pri ate indi id al(s) or b a nongo ernmental agenc, s all s prorted primaril b other than p blic f nds, and operated b other than p blicl elected or appointed officials.

**Private for-profit institution:** A pri ate instit tion in hich the indi id al(s) or agenc in control recei es compensation, other than ages, rent, or other e penses for the ass mption of risk.

**Private nonprofit institution:** A pri ate instit tion in hich the indi id al(s) or agenc in control recei es no compensation, other than ages, rent, or other e penses for the ass mption of risk. These incl de both independent nonprofit schools and those affiliated ith a religio s organi ation.

Proprietary institution: See Private for-profit institution.

**Public institution:** An ed cational instit tion hose programs and acti ities are operated b p blicl elected or appointed school officials, and hich is s proved primaril b p blic f nds.

**Quarter calendar system:** A calendar s stem in hich the academic ear consists of three sessions called q arters of abo t 12 eeks each. The range ma be from 10 to 15 eeks. There ma be an additional q arter in the s mmer.

**Race/ethnicity:** Categor sed to describe gro ps to hich indi id als belong, identif ith, or belong in the e es of the comm nit. The categories do not denote scientific definitions of anthropological origins. A person ma be conted in onlone grop.

**Race/ethnicity unknown:** Categor sed to classif st dents or emplo ees hose race/ethnicit is not kno n and hom instit tions are nable to place in one of the specified racial/ethnic categories.

Recognized Postsecondary Credential: Incl des both Title IV eligible degrees, certificates, and other recogni ed postsecondar credentials. An credential that is recei ed after completion of a program that is eligible for Title IV federal st dent aid. Credentials that are a arded to recogni e an indi id al s attainment of meas rable technical or ind str /occ pational skills necessar to obtain emplo ment or

ad ance ithin an ind str occ pation. (Generall based on standards de eloped or endorsed b emplo ers or ind str associations).

Religious affiliation/commitment (as admission factor): Special consideration gi en in the admission process for affiliation ith a certain ch rch or faith/religion, commitment to a religio s ocation, or obser ance of certain religio s tenets/lifest le.

\*Religious counseling: One-on-one or gro p co nseling ith trained professionals for st dents ho ant to e plore religio s problems or iss es.

\*Developmental services: Instrictional coirses designed for stidents deficient in the general competencies necessar for a regular postsecondar ic rric 1 m and edicational setting.

**Required fees:** Fi ed s m charged to st dents for items not co ered b t ition and req ired of s ch a large proportion of all st dents that the st dent ho does NOT pa is the e ception. Do not incl de application fees or optional fees s ch as lab fees or parking fees.

**Food and housing (charges)—on campus:** Ass me do ble occ pane in instit tional ho sing and 19 meals per eek (or ma im m meal plan).

**Secondary school record (as admission factor):** Information maintained b the secondar school that ma incl des chithings as the st dent shigh school transcript, class rank, GPA, and teacher and conselor recommendations.

**Semester calendar system:** A calendar s stem that consists of t o semesters d ring the academic ear ith abo t 16 eeks for each semester of instriction. There may be an additional s mmer session.

**Student-designed major:** A program of st d based on indi id al interests, designed ith the assistance of an ad iser.

**Study abroad:** An arrangement b hich a st dent completes part of the college program st d ing in another co ntr. Can be at a camp s abroad or thro gh a cooperative agreement ith some other U.S. college or an institution of another co ntr.

\*Summer session: A s mmer session is shorter than a reg lar semester and not considered part of the academic ear. It is not the third term of an instit tion operating on a trimester s stem or the fo rth term of an instit tion operating on a q arter calendar s stem. The instit tion ma ha e 2 or more sessions occ rring in the s mmer months. Some schools, s ch as ocational and bea t schools, ha e ear-ro nd classes ith no separate s mmer session.

Talent/ability (as admission factor): Special consideration gi en to st dents ith demonstrated talent/abilities in areas of interest to the instit tion (e.g., sports, the arts, lang ages, etc.).

**Teacher certification program:** Program designed to prepare st dents to meet the req irements for certification as teachers in elementar, middle/j nior high, and secondar schools.

**Transfer applicant:** An indi id al ho has f lfilled the instit tion s req irements to be considered for admission (incl ding pa ment or ai ing of the application fee, if an ) and ho has pre io sl attended another college or ni ersit and earned college-le el credit.

**Transfer student:** A st dent entering the instit tion for the first time b t kno n to ha e pre io sl attended a postsecondar instit tion at the same le el (e.g., ndergrad ate). The st dent ma transfer ith or itho t credit.

**Transportation (costs):** Ass me t o ro nd trips to st dent s hometo n per ear for st dents in instit tional ho sing or dail tra el to and from o r instit tion for comm ter st dents.

**Trimester calendar system:** An academic ear consisting of 3 terms of abo t 15 eeks each.

**Tuition:** Amo nt of mone charged to st dents for instrictional ser ices. T ition ma be charged per term, per co rse, or per credit.

\*Tutoring: Ma range from one-on-one t toring in specific s bjects to t toring in an area s ch as math, reading, or riting. Most t tors are college st dents; at some colleges, the are speciall trained and certified.

**Unit:** a standard of meas rement representing ho rs of academic instraction (e.g., semester credit, q arter credit, clock ho r).

**Undergraduate:** A st dent enrolled in a fo r- or fi e- ear bachelor s degree program, an associate degree program, or a ocational or technical program belo the baccala reate.

**Undergraduate Research:** Opport nities offered to ndergrad ate st dents to make original contrib tions in an academic discipline ia the e ploration of a specific research topic. Research opport nities ma or ma not be associated ith a specific co rse or earn credit.

\*Women's center: Center ith programs, academic acti ities, and/or ser ices intended to promote an nderstanding of the e ol ing roles of omen.

Work experience (as admission factor): Special consideration gi en to st dents ho ha e been emplo ed prior to application, hether for rele ance to major, demonstration of emplo ment-related skills, or as e planation of st dent s academic and e trac rric lar record.

#### FINANCIAL AID DEFINITIONS

**External scholarships and grants:** Scholarships and grants recei ed from o tside (pri ate) so rces that st dents bring ith them (e.g., Ki anis, National Merit scholarships). The instit tion ma process paper ork to recei e the dollars, b t it has no role in determining the recipient or the dollar amo nt a arded.

**Financial aid applicant:** An applicant ho s bmits **any one of** the instit tionall req ired financial aid applications/forms, s ch as the FAFSA.

**Indebtedness:** Aggregate dollar amo nt borro ed thro gh an loan program (federal, state, s bsidi ed, ns bsidi ed, pri ate, etc.; e cl ding parent loans) hile the st dent as enrolled at an instit tion. St dent loans co-signed b a parent are ass med to be the responsibilit of the st dent and **should** be incl ded.

**Institutional scholarships and grants**: Endo ed scholarships, ann al gifts and t ition f nded grants for hich the instit tion determines the recipient.

**Financial need:** As determined b o r instit tion sing the federal methodolog and/or o r instit tion's o n standards.

**Need-based aid:** College-f nded or college-administered a ard from instit tional, state, federal, or other so rees for hich a st dent m st ha e financial need to q alif. This incl des both instit tional and non-instit tional st dent aid (grants, jobs, and loans).

**Need-based scholarship or grant aid:** Scholarships and grants from instit tional, state, federal, or other so roes for hich a st dent m st ha e financial need to q alif.

**Need-based self-help aid:** Loans and jobs from instit tional, state, federal, or other so roes for hich a st dent m st demonstrate financial need to q alif.

Non-need-based scholarship or grant aid: Scholarships and grants, gifts, or merit-based aid from instit tional, state, federal, or other so rees (incl ding nrestricted f nds or gifts and endo ment income) a arded solel on the basis of academic achie ement, merit, or an other non-need-based reason. When reporting q estions H1 and H2, non-need-based aid that is sed to meet need sho ld be co nted as need-based aid.

Note: Suggested order of precedence for counting non-need money as need-based:

- 1. Non-need instit tional grants
- 2. Non-need t ition ai ers
- 3. Non-need athletic a ards
- 4. Non-need federal grants
- 5. Non-need state grants

- 6. Non-need o tside grants
- 7. Non-need st dent loans
- 8. Non-need parent loans
- 9. Non-need ork

**Non-need-based self-help aid:** Loans and jobs from instit tional, state, or other so rces for hich a st dent need not demonstrate financial need to q alif.

**Work study and employment**: Federal and state ork st d aid, and an emplo ment packaged b o r instit tion in financial aid a ards.
